OUR COMMITMENTS & TARGETS

Compliance: Adherence to all applicable regional environmental laws and regulations, alongside alignment with recognized international standards.

Climate Action:

- Commitment to achieve a 42% reduction in greenhouse gas emissions (Scope 1&2) by 2030, against a 2021 baseline, in alignment with the target established under the Science Based Targets initiative (SBTi).
- Assessment and progressive reduction of Scope 3 emissions, with focus on supply chain and customer-related impacts.

Energy and Resources

- Expansion of renewable energy use across marinas and delivery of year-on-year improvements in energy efficiency.
- Reduction of waste generation, increased recycling rates, and promotion of initiatives for waste removal from the sea and marina areas.
- Optimization of freshwater use and implementation of water-saving technologies to protect local resources.

Biodiversity & Ecosystems

- Safeguarding of marine ecosystems through pollution prevention and enhancing of biodiversity conservation initiatives.
- Commitment that at least 90% of marina employees complete chemical and oil spill prevention and response training by the end of 2026.

Sustainable Procurement

- Integration of environmental and social responsibility criteria into supplier selection and contracts.
- Encouragement for suppliers and contractors to adopt environmentally responsible practices and support our sustainability goals.

Transparency & Continuous Improvement

- Monitoring, measuring, and reporting environmental performance annually, aligned with global frameworks such as GRI and the UN Sustainable Development Goals.
- Participation in independent ESG assessments, using results to drive improvement.
- Annual review of this policy to ensure alignment with evolving best practices and stakeholder expectations.

Employee & Stakeholder Engagement

Awareness raising, training, and active engagement of employees, customers, and stakeholders to support environmental commitments.

Our target is to train at least 90% of our operational employees on oil spill prevention
